The New York State Department of Environmental Conservation – Division of Environmental Remediation (NYSDEC-DER) and New York State Department of Health – Bureau of Environmental Exposure Investigation (NYSDOH-BEEI), collectively referred to as the Departments, have completed their review of the revised Remedial Investigation Report (electronically received/signed on 08/30/2023) as prepared by ERM Consulting and Engineering, Inc.


In accordance with Title 6 of the New York Codes, Rules, and Regulations (6-NYCRR) part 375-1.6, the Departments have determined that the revised RIR substantially addresses the requirements of the Brownfield Cleanup Agreement, and the report is hereby **approved**.

The Departments are required to determine whether a given site constitutes a significant threat to public health and/or the environment no later than 20 days after a remedial investigation report is approved. After a review of data collected throughout the Remedial Investigation, the Departments determined that the site should be classified as a significant threat pursuant to NYCRR part 375-3.7.

As a result of the significant threat determination, the Departments are authorized to select the site's remedy from the forthcoming Alternatives Analysis Report. The remedial investigation report results as well as the Significant Threat Determination were communicated to the public in a NYSDEC-DER issued fact sheet on November 22, 2023.

Within 10 days from the date of this letter, please compile the final document with this approval as cover and place a copy in the document repository for the site.
